Who requires training?

All staff (including Primary Care staff) require **Safeguarding Adult** training every 3 years. This is a mandatory requirement. All ICB Staff require **PREVENT** training, every 3 years. This is also mandatory.

The following page, page 4, shows forthcoming NHS Derby and Derbyshire ICB training dates.

As outlined in the [Adult Safeguarding: Roles and Competencies for Health Care Staff Guidance \(2024\)](#) GPs and Practice Nurses require 3 hours safeguarding adult training annually (totalling a minimum of 8 hours over 3 years). This can include any of the following related subjects :-

In addition to the safeguarding leads meetings, the safeguarding team are going to offer a drop in service once a month on the fourth Thursday of the month (omitting December).

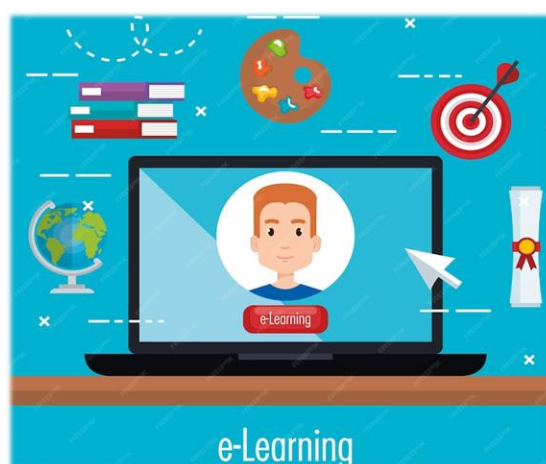

N.B. The Adult Safeguarding Role and Competencies for Health Care Staff Guidance states that a Minimum 50% of the learning should be delivered/met through participatory opportunities (where discussion can take place with colleagues with sufficient safeguarding experience). Participatory learning includes face to face, online virtual classrooms, hybrid methodology.

E-learning should not be the primary or sole delivery method for healthcare staff.
